# Citizen Inquiries and Community Engagement



## **Overview**

Our specialist community engagement work, led by Peter Bryant, can really have an impact. This is exemplified by our facilitation of **citizen led inquiries** on difficult topics such as alcohol use, Fracking or the reform of mental health services.

Through citizen juries, community-led design and our knowledge exchange work with higher education, we seek to work closely with local people and to build their social capital.

We help communities, and especially the individuals within communities that most marginalised from public engagement processes, to explore issues of public policy in inclusive ways.

### **Case Study: Wirral Alcohol Inquiry**

Commissioned by Wirral Borough Council and led by Shared Future, local residents considered "What can we all do to make it easier for people to have a healthier relationship with alcohol?" Over nine sessions, they were encouraged to think and talk about the impact of alcohol in their community. The group included people with direct experience of alcohol harm and those with none.

In the first session the group used participatory tools such as mapping and problem trees to talk about local assets and barriers. In the remaining sessions commentators were invited to present to the group on the issues prioritised by them during the first session. During the last two sessions the group produced a set of 21 prioritised recommendations.

Following on from the inquiry they presented the results to politicians, health service managers and other key stakeholders with the aim of changing how local policies and services were implemented.

The citizen-led recommendations focused on licensing, community facilities and activities, advertising, sales and availability, education, awareness and public services. The primary recommendation emerging from the deliberations of the Inquiry was to:

"Limit the number of licensed premises and make it easier for the public to object to new ones opening. Educate the public that you can have a say on local licensing. Explore how we can make it easier for the public to have their say on local licensing."
